



Fingerprinting Rule Requirement Out-of-Country Deadline Extension Request

COVER PAGE

An Out-of-Country Extension provides an opportunity for an attorney residing outside of the United States to request additional time to submit fingerprints to the DOJ and FBI without incurring any penalty.

Attorneys requesting an extension must submit an Out-of-Country Deadline Extension form postmarked or emailed by July 31, 2019, or be subject to penalties.

Documentation for proof of current residence cannot include a date that is more than 90 days from the application submission date. Below are examples of what can be accepted for proof of residence:

- Utility Bill (i.e. telephone, gas, electric). Please note that a mobile phone bill will not be accepted as a valid Proof of Residence.
- Bank Statement
- Mortgage Statement
- Signed Lease Agreement still within term
