# Acknowledgement and Acceptance of Testing Conditions February 2021 California Bar Examination

The California Bar Examination, scheduled to be administered on February 23—24, 2021, will be a remote, online administration. In-person exam administration will be available to those with granted testing accommodations that cannot be effectively provided and securely administered in a remote environment. There will also be limited space available for applicants who certify under penalty of perjury that they do not have access to or the ability to obtain a quiet testing space or a reliable Internet connection, as described below.

#### **Exam Format**

## A complete list of all required equipment is posted as part of the February Bar Exam FAQs.

- 1. Applicants must take the examination on a laptop computer with a functional internal webcam and microphone (required for ExamID and ExamMonitor). The camera and microphone must be on and unobstructed at all times during the exam session.
- 2. Applicants must personally install and certify the required exam software on their laptops (which will require downloading the latest version of Examplify), and their laptops must have:
  - a. Mac Operating System: OS X 10.14 (Mojave), macOS Catalina (10.15), macOS Big Sur (11.0). Only genuine versions of Mac operating systems are supported.
  - b. CPU: Intel processor. (Devices using Apple's M1 chipset are not supported.)
  - c. Windows Operating System: 10 (Version 1803, 1809, 1903, or 1909)
  - d. Operating System: 32-bit and 64-bit Versions of Windows 10
- 4. The first day of the California Bar Exam will be comprised of five one-hour essay questions and a 90-minute Performance Test question, with a one-hour lunch break.
- 5. On the second day of the California Bar Exam, the Multistate Bar Examination (MBE) will be administered. The MBE will consist of 200 multiple-choice questions, split into four 50-question sessions tested over 90 minutes each, with a one-hour lunch break.
- 6. The first day of testing will also constitute the Attorneys' Examination. Qualified attorney applicants are not required to take the MBE, but may opt to do so by enrolling for and taking the full California Bar Examination.
- 7. There will be 30 minutes between the times that passwords are released and the start of the next exam session. When the password is entered, the exam session will begin and the timer will start counting down. Applicants should not enter the password for a session until they are ready to begin. Applicants who log in early may begin the session early, but doing so will not gain extra session time. On Day 1, there will be a 90-minute lunch break between Essay 3 and Essay 4. On Day 2, there will be a 90-minute lunch break between Part 2 and Part 3 of the MBE. Other than during these scheduled breaks, applicants are NOT permitted to leave the view of their web camera unless they finish early and upload their answers.
- 8. At the start of each session, applicants will log into the session and verify Identification against a baseline photo ID taken during the mock exam. If an applicant has not logged on within 15 minutes of

- the start of a session (after the scheduled break time), they will not be permitted to log into that exam session.
- 9. An applicant must be alone in the room where they are taking the exam, and no other person may enter the room or communicate in any manner or by any means with the applicant during the exam for any purpose.
- 10. If an applicant's Internet connection disconnects or malfunctions for any reason during the log-on periods for the exam session, the applicant will be able to obtain a resume code from ExamSoft technical support and enter the exam session before the end of the log-on period. At no point will applicants be able to enter the session after the close of the log-on period.

## **Exam Conduct and Sanctions**

It is expected that all applicants will demonstrate integrity, honor, and ethical behavior during this exam, and all exams administered by the State Bar of California. This remote-proctored exam will be continuously monitored by artificial intelligence and human proctors, and any and all anomalies or suspicious behavior will be flagged. Flagged video files will be reviewed by the State Bar to determine if there are any conduct violations. Conduct violations will result in strict sanctions. Sanctions may include, but are not limited to: a zero for the exam session, a zero for the entire exam, and/or a negative impact on the applicant's moral character determination.

The following conduct will be **prohibited**:

- 1. Leaving the view of the webcam outside of scheduled breaks.
- 2. Any attempt to bypass or avoid the remote proctoring mechanisms and protocols, or to obtain or receive assistance on the exam.
- 3. Individuals (other than the applicant) coming into the exam room.
- 4. Having cell phones or other electronic devices, including a tablet or additional computers or monitors, in the exam room or connected remotely to any other devices or equipment in the exam room
- 5. Having notes, study aids, or other papers or exam resources in the exam room, including scratch paper (digital scratch paper will be provided). The only exception is the allowance of a maximum of 8 pieces of blank scratch paper (16 sides, maximum size 8.5" x 11") during the Performance Test portion of the exam only, which is to be displayed (front and back) to the webcam at the beginning of the session.
- 6. Having digital timers, watches, or clocks in the exam room (the exam software has a built-in timer that allows applicants to set timed reminders).
- 7. Having books of any kind in the exam room within view or reach of the applicant.
- 8. Having food or beverages, including but not limited to coffee and water, in the exam room (unless you have been granted a testing accommodation that allows for these items). Smoking during the exam is not allowed.
- 9. Having in the exam room any item(s) other than the allowed items listed in the Admittance Bulletin (unless you have been granted a testing accommodation that allows for these items).
- 10. Having any radios, stereos, or other devices/equipment that can make audible sounds in the exam room. Any such items must be turned off at all times during the exam and scheduled breaks.

You must acknowledge receipt and understanding of the above by signing and returning the attached Release of Liability, Acknowledgement and Acceptance of Testing Conditions by 11:59 p.m. (Pacific Daylight Time) on January 15, 2021, through the applicant portal. Forms that have been amended or altered in any way will not be accepted. You need to return this form even if you have approved or pending testing accommodations. If you are unable to meet the conditions of the exam and need to withdraw your exam registration, please contact the Office of Admissions through the applicant portal. Failure to submit the Acknowledgement by the deadline will result in the abandonment of your application and ineligibility for a refund of exam fees.

All applicants were originally assigned to the online exam. Please select one of the following options to proceed. If you choose extenuating circumstances, this is not the proper place to request testing accommodations; you must petition for testing accommodations through the normal process and in compliance with the published deadlines.
