## THE PRESIDENT'S PRO BONO SERVICE AWARDS



The State Bar Board of Governors established the President's Pro Bono Service Awards in 1983 to provide statewide recognition of attorneys for outstanding provision of pro bono legal services to the poor. Awards categories beginning 2001 were reconfigured to fully ensure that lawyers from a wide scope of settings be recognized for their extraordinary provision of pro bono legal services to low income individuals or organizations whose primary purpose is to serve the poor.

These awards are given for probono contributions provided during 2000.

## The following factors are taken into consideration in the selection process:

- \* breadth and impact of nominee's work
- \* nominee's practice setting
- \* nature of pro bono program through which the work is done
- \* evidence of nominee's commitment to pro bono work
- \* nature of services contributed

Mr. Bowman, an international tax research manager, has advised and represented low-income clients, predominately those with HIV/AIDS, cancer and the disabled, with their tax problems for the past 12 years through the Bar Association of San Francisco Volunteer Legal Services Program (VLSP) and its Homeless Advocacy Project (HAP) and the AIDS Legal Referral Panel. Mr. Bowman helped write the tax law section of HAP's Advocates Manual and was instrumental in establishing a pro bono panel of tax lawyers. He continues to serve as a mentor and recruiter of fellow tax attorneys for VLSP's Low-income Tax Clinic.

She provided a variety of consultations to indigent clients in the areas of debtor relief, family law, estate planning, landlord/tenant, contracts, domestic violence and SSI Appeals through SDVLP's AIDS Law Team, SSI Appeals Project, Domestic Violence Prevention Project, and Family Law Access Project. Additionally, she mentored and trained other attorneys and law students at the clinic on procedural and legal issues, enabling them to effectively interview, advise and serve more clients in need of legal assistance.

### Debora S. Vierra and Laura V. Bartels Fillmore

Debora S. Vierra founded the Santa Clara Valley Legal Aid clinic in 1996 when she was a new admittee and was joined shortly thereafter by Laura V. Bartels, a partner with the Fillmore law firm of Taylor, Scoles and Bartels. With few resources or funding, the clinic operates every Thursday evening from a community storefront in a low-income neighborhood of Fillmore, a remote agricultural community twenty miles from Ventura. The clinic provides free legal counseling in a wide variety of legal matters for many, including non-English speaking migrant farm workers and working class families. Staffed by volunteer attorneys, a Spanish-speaking translator and community representatives, the clinic also provides educational seminars on legal topics for the general public. Ms. Vierra and Ms. Bartels are in private practice and have been active volunteers with the Ventura County Bar Association's Volunteer Lawyers Program since 1997.

#### SOLO PRACTITIONER

#### Stephanie M. Simpson Northridge

Well past retirement age, Ms. Simpson devoted more than one-half of her professional life to providing pro bono representation to elderly, indigent and disabled clients in administrative appeals for denial of SSI disability claims and in appeals to the United States District Court. She was successful in more than 90% of the cases she handled and also continues to guide young lawyers and law students.
