STATE BAR'S COMMITMENT TO PRO BONO

Originally adopted by the Board of Governors in December 1989, the State Bar's Pro Bono Resolution encourages all attorneys to contribute at least 50 hours per year of pro bono service. In June 2002, the Resolution was amended to reflect an updated and renewed commitment to serving the legal needs of low- and moderate income Californians. The revisions strengthen the original resolution by

- · acknowledging judicial support for pro bono
- urging law schools to promote and encourage law student pro bono participation and
- adding an option to support pro bono through financial contributions.

The resolution also references California Business and Professions Code Section 6068 (h) that establishes it is the duty of a lawyer "Never to reject, for any consideration personal to himself or herself, the cause of the defenseless or the oppressed."

Local bar associations are encouraged to revisit their commitment to pro bono and to adopt similar resolutions.

On behalf of the State Bar of California, I am honored to recognize the recipients of the 2003 President's Pro Bono Service Awards and the Loren Miller Legal Services Award.

A perfect storm threatens access to justice in California. Path to Equal Justice, a recent study by the Commission on Access to Justice, teaches us 72% of low income Californians cannot afford basic legal services. The statewide ratio of low-income individuals to

legal services lawyers is ten thousand to one and, in some counties, thirty thousand to one. Falling interest rates mean ever diminishing IOLTA funds for legal services programs. We risk justice becoming a two-tiered system: one for the wealthy and one for the poor. As Chief Justice George has said, "If the motto and justice for all becomes and justice for those who can afford it, we threaten the very underpinnings of our social contract."

Those we honor stand in the face of this perfect storm setting an example for all of us to follow. As President of the State Bar, they make me proud to be a lawyer. I encourage you to consider how you can help ensure meaningful access to the legal system. There are endless opportunities for you to address this, the greatest challenge facing our profession. Help us realize the State Bar motto, "To preserve and improve the justice system in order to assure a fair and just society under the law."

Ms. Stewart is a Senior Appellate Attorney for the California Court of Appeal, Fourth Appellate District, Division One. For the past two years Ms. Stewart has co-chaired the Women's Resource Fair, an annual community

outreach event targeted to low-income women and children affected by homelessness, domestic violence or other social problems, sponsored in part by the San Diego Volunteer Lawyer Program. The event helps hundreds of women and children find legal, medical and social services. She has been involved in the event since 1997 and is working on the 2004 event.

Arthur Chettle has been a solo practitioner for 13 years specializing in debt relief and bankruptcy. Since 1996 Mr. Chettle has been a dedicated and devoted pro bono attorney at the Legal Clinic of the San Diego Volunteer

Lawyer Program's AIDS Law Project, counseling and advising clients on bankruptcy and tax issues, and accepting virtually every bankruptcy case offered by SDVLP. Mr. Chettle also mentors law students and newly admitted attorneys. He has been recognized by SDVLP with their Distinguished Service Award for the past five years.

Government: Steven Binder, San Diego



Mr. Binder is a Deputy Public Defender who helped create the state's first Homeless Court in 1989. The program has served as a model for other jurisdictions including Sacramento, Los Angeles, Riverside and

Ventura Counties. It is held monthly at a homeless shelter and assists the homeless resolve legal problems usually involving minor offenses arising out of the condition of being homeless. Mr. Binder meets with defendants prior to court to review their progress completing treatment programs, counseling or community service obligations. He also wrote a manual for the ABA on how to implement Homeless Court.

O Los Angeles and San Francisco offices assisted in the creation of a statewide pro bono project for California families affected by the September 11, 2001 tragedy. Forty attorneys in both locations devoted more than 2,300 pro bono hours in partnership with

- the Volunteer Legal Services Program of the Bar Association of San Francisco, Public Counsel and the Los Angeles County Bar Association.
- San Francisco office received the inaugural Partners for Justice Legal Impact Award from Asian Pacific Islander Legal Outreach for pro bono representation of immigrant domestic violence survivors who are self-petitioning for legal permanent residence. Attorneys also volunteered with the Prison Law Office on matters involving parole and conditions in the California Youth Authority.
- James Barrall of the Los Angeles office organized a team of 15 Latham attorneys that co-counseled with Inner City Law Center and secured a multi-million dollar settlement to compensate more than 100 tenants, mostly low-income children and immigrants, left homeless when a substandard apartment partially collapsed.
- Amos Hartston coordinated the pro bono committee and supervised the pro bono work of the Los Angeles office, in addition to providing hundreds of hours of direct pro bono service to 9/11 families through Public Counsel; to unaccompanied juveniles in INS detention in connection with applications for asylum through the Catholic Legal Immigration Network (CLINIC); and to low-income tenants in unlawful detainer cases and a non-profit organization in a real estate fraud case with Bet Tzedek Legal Services.
- A team of attorneys from the San Diego office, Joseph Wheeler, Shannon Petersen, Ward Lott and Joel Mark, spent more than 1,500 hours on a case referred by the San Diego Volunteer Lawyer Program representing a severely disabled 9 year old boy in a difficult and emotional matter involving complex litigation against a school district. Though the decision was in favor of the school district, the team succeeded in effecting changes to the district's use of restraints on disabled children.
