This is a one-time extension granted by the California Board of Legal Specialization.**

Certified specialists in MCLE Compliance Group 2 must use this compliance card to report completion of the legal specialist education requirement of 36 hours of legal specialist approved education or an equivalent during the compliance period of February 1, 2015 through July 1, 2018.

Qualifying equivalent courses and activities include authoring scholarly articles in the specialty area, completing MCLE approved courses in the specialty area, and teaching in legal specialist approved or MCLE approved courses in the specialty area (actual speaking time multiplied by four for the first presentation only).

Note that this form is only for reporting your legal specialist education compliance. You must still separately log on to your My State Bar Profile to report your MCLE Compliance if you have not already done so. You must also separately recertify as a legal specialist every five years on the same recertification schedule you have always used. The Department of Legal Specialization will continue to send you reminders as your recertification date approaches.
