~~[Deleted text begins]To ensure that prospective students of, applicants to, and students of a law school's J.D. degree program are fully informed about the requirements and possible limitations associated with attending and graduating from an accredited law school, [Deleted text end]~~ An accredited law school must include the following statement, without alteration, in ~~[Inserted text begins]either[Inserted text ends]~~ its course catalog ~~[Deleted text begins]and on the principal page of the website for its J.D. program:[Deleted text end]~~~~[Inserted text begins]or student handbook (electronic or hardcopy) and on a discrete page readily accessible to the public found on the law school's website entitled "Accreditation" on which the law school refers to its status as being accredited by the Committee and any other regional or national accrediting entity or agency:[Inserted text ends]~~

~~[Deleted text begins]"[Deleted text end]~~Study at, or graduation from, this law school may not qualify a student to take the bar examination or be admitted to practice law in jurisdictions other than California. A student who intends to seek admission to practice outside of California should contact the admitting authority in that jurisdiction for information regarding its education and admission requirements.
