**Important Dates and Deadlines for the July 2009 California Bar Examination:**

**DATE:** Tuesday, Wednesday and Thursday, July 28, 29 and 30, 2009

**TIME:** Examination sessions begin at 9:00 a.m. and conclude at 5:00 p.m. each day. Applicants will be required to arrive earlier; however, to receive instructions before each session begins. More specific information concerning the timing will be sent with admittance tickets.

Results from the July 2009 California Bar Examination are scheduled to be mailed to applicants on Friday, November 20, 2009. **Applicants will need their File Number and Applicant Number as shown on their admittance tickets and ID badges to access the pass list.**

As of Sunday, November 22, 2009, at 6:00 a.m., the pass list will be available to the general public on the State Bar's home page. Beginning Monday, November 23, 2009, at 8:45 a.m., pass list information will be available over the telephone through the State Bar's Los Angeles and San Francisco Admissions offices. Pass lists will also be available for viewing in both offices.
