Dear Participant:

**NEW LOCATION** - The 60<sup>th</sup> *Annual Bench and Bar Art Exhibit* will be on display in the San Carlos Ballroom Foyer, Monterey Marriott from Thursday, October 11 through Saturday, October 13. You are invited to enter your best works and participate in this enjoyable event.

To participate in this year's show, art pieces must be delivered directly to the San Carlos Ballroom Foyer on Thursday, October 11, from 8:00 a.m. – 2:00 p.m. The art show must be set up by 3:00 p.m. on Thursday, October 11, and ready for judging and unveiling by 5:30 p.m. The Exhibit will be open for general display on Thursday, October 11, 5:30 p.m. - 7:00 p.m., Friday, October 12, 7:30 a.m.-5:00 p.m., and Saturday, October 13, 7:30 a.m. – 5:00 p.m.

Upon closing, on Saturday, October 13 at 5:00 p.m., the Art Exhibit will be dismantled. Entrants are responsible for removing art exhibit pieces at this time, but not later than 9:00 a.m. on Sunday, October 14. The display and removal of art pieces is the sole responsibility of the entrant. You must be present to remove your artwork. It is NOT the responsibility of the Chairs to remove your art. **NOTE: There will be no transportation of artwork to or from the Exhibit, nor will there be any insurance provided for the entries during the show. If you are concerned about the possibility of loss or damage to your work, you should obtain your own insurance coverage.**

To insure the success of your exhibit, **the committee needs your help.** We need volunteers to hang the show on Thursday, October 11, to staff the show throughout the meeting and to take down the exhibits on Saturday, October 13 and Sunday, October 14. Since this is your show, please consider volunteering an hour or two of your time to help staff the show. Please indicate your willingness to participate in these activities in the space provided on the entry blanks. We particularly need your help hanging the art. The time spent at the art show is very enjoyable. You have the opportunity to meet your colleagues and share your artistic interests with them. Your willingness to volunteer your time and talents will assure an enjoyable, successful show!

Catalogues and award ribbons will be provided at the show. An entry blank and identification form is enclosed. Please complete your entry blanks and send them to Art Show Coordinator, Department of Meeting Services, State Bar of California, 180 Howard Street, San Francisco, CA 94105. It is important for the committee to have an early indication of the size and content of the show. **Entry deadline is September 14, 2012.**
