

## ADMISSION TO PRACTICE LAW IN CALIFORNIA

Congratulations! You have satisfied the requirements for admission to practice law in California, and the Committee of Bar Examiners of The State Bar of California (Committee) will obtain an order from the Supreme Court of California permitting you to take the attorney's oath of office on or after May 29, 2001 before a Judge, Justice or Clerk of a Court of Record, Commanding Officer if in the military service, the American Consul if in a foreign country or a notary public. In California, a Court of Record includes Municipal and Superior Courts, the Courts of Appeal and the Supreme Court. Also, in California, the following officials are authorized to administer the attorney's oath: court commissioners, notary publics, shorthand court reporters, any member of the legislature, any county officer and members of the State Bar Board of Governors. Specific information regarding registration and fees and a membership enrollment card are enclosed. The Committee has made arrangements for admission ceremonies to be held in several cities. You may attend one of the admission ceremonies that will be held before the California Courts of Appeal at the times and places indicated below. You are not required to attend an admission ceremony to take the attorney's oath. You may take the oath before any of the officers noted above.

Your bar examination results are valid for five years from the last day of the examination you passed. Once you have been informed that you have fulfilled all the requirements for admission to practice law and that your name was placed on a motion to the Supreme Court, it is not necessary to file any additional applications or reapplications, including moral character, during the period between the date of the examination you passed and the expiration of five years from that date, before taking the attorney's oath. However, until you have taken the attorney's oath and been admitted to the State Bar of California, you have a continuing duty to notify the Committee of Bar Examiners in the event there is a change or addition to the information previously furnished on the moral character determination application.

**ADMISSION TO THE UNITED STATES  
DISTRICT COURT**

**Northern District**

Immediately following the ceremony for admission to practice in the California courts, the United States District Court for the Northern District of California will convene for the purpose of admitting interested applicants to the bar of that Court. If you wish to be admitted to that Court at that time, you must take the District Court oath during the ceremony and pick up your validation card and instructions at the conclusion of the ceremony. Your District Court certificate will be mailed to you within several weeks following the ceremony.

**Eastern District**

In Fresno, immediately following the ceremony for admission to practice in the California courts, the United States District Court for the Eastern District of California will convene for the purpose of admitting interested applicants to the bar of that Court. If you wish to be admitted at that time, you must complete an admission card, submit a payment in the amount of \$80.00, and take the oath administered during the admission ceremony. Your District Court admission certificate will be mailed to you within 4-6 weeks following the ceremony. In Sacramento, the ceremony to be admitted into the United States District Court will be held at the U. S. District Courthouse, 501 "I" Street, Sacramento. Information regarding the exact time of this ceremony will be available at the ceremony for admission to practice in the California courts.

If you are unable to attend the ceremony, you may be admitted by mail. Please send a self-addressed stamped envelope to the Clerk's Office at 650 Capitol Mall, Room 2546, Sacramento, CA 95814 or 1130 "O" Street, Room 5000, Fresno, CA 93721, Attn: Attorney Admissions, to receive more information.

**Central District**

**Los Angeles County:**

Immediately following the ceremony for admission to practice in the California courts, the United States District Court for the Central District of California will convene for the purpose of admitting interested applicants to the bar of that Court. If you wish to be admitted to that Court at that time, you must take the District Court oath during the ceremony. A representative from the U.S. District Court will be available, prior to the ceremony, to answer questions and to distribute admission packets. Please bring a 9" by 12" self-addressed, stamped envelope, with support to protect the certificate (cardboard inserts or a photo mailer). A check for the amount of \$85.00, payable to the Clerk of the Court must also be submitted. If you are unable to attend the ceremony, please contact the Attorney Admission's office nearest you and leave your name and address and an application will be mailed to you: Central Los Angeles (213) 894-2085; Orange-Southern Division (714) 836-2467; and Riverside-Eastern Division (909) 276-6169. **CAUTION!**

The *Rules Regulating Admission To Practice Law In California* provide that if you have not taken the attorney's oath within five years after the last day of the bar examination which you passed, you become ineligible for admission.

**TRANSFER OF MBE SCORES TO OTHER  
JURISDICTIONS**

The National Conference of Bar Examiners will transfer your MBE score to the admitting authorities in other jurisdictions upon **written** request. If you wish to have this done, you should make a **written** request to MBE Score Transfer Department, Operations/82, P. O. Box 168, Iowa City, IA 52243-0168. Please do not telephone. Provide your social security number, the examination date (month and year), location (state) and jurisdiction to which you wish score mailed. The Conference requires a fee of \$25.00 for each transfer search or request for verification or advisement of an MBE score. Checks should be made payable to the National Conference of Bar Examiners.

**CERTIFICATE OF ADMISSION**

There is a \$48.00 charge for a customized certificate, 11"x 14" on cream parchment, suitable for framing. It includes the gold Supreme Court seal and the attorney's name and date of admission are lithographically impressed to match the certificate text. If you decide to order a customized certificate, you must initial the appropriate box on the back of the membership enrollment card.

Do not submit payment now. The \$48 charge for this certificate will be included on your regular fee statement.

A standard, 8½" x 12" certificate printed on card stock with typewritten name and date of admission is also available, at no cost, by initialing the appropriate box on the back of the membership enrollment card. **The name under which you are admitted is the name that will appear on the Admission Certificate.**
