It was moved, seconded and duly carried that following a period of public comment during which no comments were received, the amendment to Rule 4.161 of the *Accredited Law School Rules* and to the Law School Fees Charges and Deadlines in the form below be approved and forwarded to the Board of Trustees with a request that they be approved:

- (A) A law school subject to these rules must submit an Annual Compliance Report using the form prescribed by the Committee. The deadline and fee for submission of the report are set forth in the Schedule of Charges and Deadlines.
- (B) A law school with an approved branch or satellite campus must submit an annual fee for each additional campus as set forth in the Schedule of Charges and Deadlines.

PROPOSED AMENDMENTS TO LAW SCHOOL RULES RE ADDITIONAL DISCLOSURES – RETURN FROM PUBLIC COMMENT

It was moved, seconded and duly carried that following a period of public comment during which two comments were received and considered, the following proposed amendment of Rule 4.241(A) of the *Unaccredited Law School Rules*, which will require unaccredited law schools to provide attrition rates in their disclosure statements, be adopted:

(10) In the format required by the Committee, the attrition rates of students who are enrolled in the school and do not matriculate into subsequent years of law study. This information must be provided for the past five years or since the establishment of the law school, whichever time is shorter.

And that the adopted amendment be forwarded to the Board of Trustees for approval.

PROPOSED AMENDMENTS TO GUIDELINES 15.2 – 15.3 OF THE GUIDELINES FOR ACCREDITED LAW SCHOOL RULES (OPENING AND OPERATING BRANCH OR SATELLITE CAMPUSES

It was by common consent agreed that consideration of the proposed amendments to Guidelines 15.2 and 15.3 of Division 15 (Opening and Operating Branch and Satellite Campuses) to the *Guidelines for Accredited Law School Rules* be deferred until the next meeting of the Committee.

SAN FRANCISCO LAW SCHOOL – MAJOR CHANGE REQUEST

It was moved, seconded and duly carried that the Request for Approval of Major Change submitted by the San Francisco, pursuant to Rules 4.164 and 4.165(B) the *Accredited Law School Rules*, regarding the relocation of its campus and classrooms to One Beach Street, San Francisco be received and filed; and that the request be granted.

TRINITY LAW SCHOOL – REQUEST FOR MAJOR REQUEST

It was moved, seconded and duly carried that the request submitted by Trinity Law School (TLS) for approval of a Major Change, which would permit TLS to offer and award a Master of Legal Studies (MLS) degree, and the Committee's acquiescence to

award the degree be received and filed; that the requests be granted, which will allow the TLS to begin offering a MLS degree on a date of its choosing; and that, the law school must include, without alteration and as set forth in Guideline 13.3, the necessary disclaimer in its course catalog and website that the degree does not qualify the recipient to take the California Bar Examination or satisfy the requirements for admission to practice law in California.

<u>CALIFORNIA DESERT TRIAL ACADEMY COLLEGE OF LAW –</u> MAJOR CHANGE REQUEST

It was moved, seconded and duly carried that the Request for Approval of a Major Change submitted by the California Desert Trail Academy College of Law pursuant to Rule 4.245 of the *Unaccredited Law School Rules*, regarding its move to its new facility, be received and filed; and that the request be granted.
