Subject: 2006 Annual Independent Auditors' Report

The President has authority to conduct, or request to be conducted, fax polls of the Board on matters of urgency that require Board approval prior to the next regularly scheduled meeting of the Board. The report is dated April 10, 2007 and was delivered electronically to the State Bar on April 19, 2007. Since the April 30th filing deadline occurs prior to the Board's next scheduled meeting, the most expeditious way for the Board to acknowledge receipt of the audit and order its filing is via fax poll. The Audit Committee will review and discuss the audited financial statements at the May meeting of the Board.

Therefore, attached is the *Independent Auditors' Report for Years Ended December 2006 and 2005*, prepared by Deloitte & Touche regarding its examination of statements of the State Bar's assets, liabilities and net assets as of December 31, 2006, and its related statements of revenues, expenses, and changes in net assets.
