SUBJECT: Status of Claims Activities – Client Security Fund
Through the Quarter Ended September 30, 2007

A series of reports are generated to report claims activity within the Client Security Fund each quarter. These reports include:

- Claims Activity for the third quarter ended September 30, 2007
- Claims Aging Report
- Cumulative Claims Aging Report
- 24 Month Rolling Average of Claims Paid
- Analysis of New Claims Paid, Rejected or Withdrawn

Through the end of September, 726 new claims in the amount of \$9.2 million were filed. By comparison, 1,119 claims in the amount of \$8.6 million were filed through the third quarter of 2006. Based on the current claims payout ratio of 42.27%, the estimated outstanding claims liability is approximately \$5.5 million. Total cash and investments available to address this liability at the end of September are \$10.2 million as compared to \$9.0 million as of the third quarter of 2006.
