

**Accredited Law School Rules  
Schedule of Charges and Deadlines**

This schedule is an appendix to Title 4, Division 2, Chapter 1, Rule 4.110 of the *Rules of the State Bar of California, (Accredited Law School Rules)*, and is subject to change. Initial deposits will be credited against charges for time and expenses. Total costs are based on actual time spent reviewing documents, traveling to, preparing for and conducting visits and inspections, preparing reports, and related activities, plus expenses. Both billings for amounts due and refunds will be made so that the school will be charged at the stated hourly rate for the time actually spent in relation to the service provided, plus expenses. The hourly rate for services of the Senior Executive, Admissions, or his or her designee, or a consultant is \$200.00.
