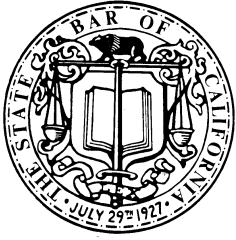

Statement of Assets, Liabilities & Net Assets:

This statement reports the Bar's assets, liabilities and net assets. For the quarter ended June 30, 2008, the Bar's total assets are \$167.6 million, liabilities are \$49.9 million and net assets are \$117.7 million. The General Fund, the Bar's largest operating fund, has assets of \$53.9 million, liabilities of \$42.8 million and net assets of \$11.1 million. Individual statements for the General Fund and the restricted funds are included for your reference.

Statement of Revenue, Expenses and Changes in Net Assets

This statement reports the Bar's revenues, expenses, excess (deficiency) of revenues over expenses and changes in net assets. For the quarter ended June 30, 2008, the Bar's total

revenues (operating and non-operating) are \$88.1 million, and expenses are \$56.6 million, resulting in a surplus of \$31.5 million.

The General Fund's total revenues through the end of second quarter are \$32.8 million, which represents a \$0.2 million increase from the total revenues of \$32.6 million for the second quarter ended 2007. The increase is attributable to a \$0.7 million increase in membership fees, and a \$0.1 million increase in continuing legal education fees and seminar workshop revenue, partially offset by a decrease in investment income of \$0.6 million due to decrease in interest rate in the current year.

Budget to Actual Comparison – General Fund

Each quarter, a budget to actual comparison report for the General Fund is prepared. This statement is designed to provide the Board with information about how the actual performance of the General Fund's revenues and expenses compares with anticipated (budgeted) results. The report includes a quarterly budget comparison as well as year to date and prior year comparison.

Year to date, the General Fund's total revenues reflect a favorable variance of \$2.3 million, which represents 7.6% of the year-to-date budget. The variance is due to a \$1.9 million increase in membership fees, a \$0.4 million increase in continuing legal education.

Total General Fund expenses through the second quarter show a favorable variance of \$0.3 million, which reflects the decreases in discipline, and administrative functional areas.

The General Fund Budget to Actual Comparison Expenses by Function report reflects the expense variance by functional area, and variances at the total program level are insignificant.

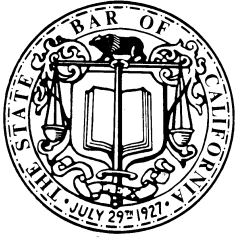

Statement of Assets, Liabilities & Net Assets:

This statement reports the Bar's assets, liabilities and net assets. For the quarter ended September 30, 2008, the Bar's total assets are \$149.1 million, liabilities are \$47.8 million and net assets are \$101.3 million. The General Fund, the Bar's largest operating fund, has assets of \$44.6 million, liabilities of \$33 million and net assets of \$11.6 million. Individual statements for the General Fund and the restricted funds are included for your reference.

Statement of Revenue, Expenses and Changes in Net Assets

This statement reports the Bar's revenues, expenses, excess (deficiency) of revenues over expenses and changes in net assets. For the quarter ended September 30, 2008, the Bar's total

revenues (operating and non-operating) are \$117.6 million, and expenses are \$102.5 million, resulting in a surplus of \$15.1 million.

The General Fund's total revenues through the end of third quarter are \$48.3 million, which represents a \$0.3 million decrease from the total revenues of \$48.6 million for the third quarter ended 2007. The decrease is attributable to a decrease in investment income of \$0.9 million due to the financial crisis in the current year, partially offset by an increase in membership fees for \$0.6 million.

Budget to Actual Comparison – General Fund

Each quarter, a budget to actual comparison report for the General Fund is prepared. This statement is designed to provide the Board with information about how the actual performance of the General Fund's revenues and expenses compares with anticipated (budgeted) results. The report includes a quarterly budget comparison as well as year to date and prior year comparison.

Year to date, the General Fund's total revenues reflect a favorable variance of \$2.6 million, which represents 5.7% of the year-to-date budget. The variance is due to a \$2.3 million increase in membership fees, a \$0.6 million increase in continuing legal education and other revenue, partially offset by a \$0.3 million decrease in the CalBar Journal revenue.

Total General Fund expenses through the third quarter show a favorable variance of \$0.8 million, which reflects the decreases in governance functional areas.

The General Fund Budget to Actual Comparison Expenses by Function report reflects the expense variance by functional area, and variances at the total program level are insignificant.

Through the end of June, 434 new claims in the amount of \$5.39 million were filed. By comparison, 469 claims in the amount of \$5.1 million were filed through the second quarter of 2007. Based on the current claims payout ratio of 42.86%, the estimated outstanding claims liability is approximately \$5.6 million. Total cash and investments available to address this liability at the end of June are \$6.8 million as compared to \$6.6 million as of the second quarter of 2007.

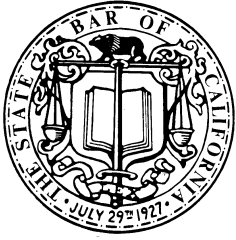

SUBJECT: Status of Claims Activities – Client Security Fund
Through the Quarter Ended September 30, 2008

A series of reports are generated to report claims activity within the Client Security Fund each quarter. These reports include:

- Claims Activity for the quarter ended September 30, 2008
- Claims Aging Report
- Cumulative Claims Aging Report
- 24 Month Rolling Average of Claims Paid
- Analysis of New Claims Paid, Rejected or Withdrawn

Through the end of September, 647 new claims in the amount of \$8.95 million were filed. By comparison, 726 claims in the amount of \$9.2 million were filed through the third quarter of 2007. Based on the current claims payout ratio of 42.71%, the estimated outstanding claims liability is approximately \$5.5 million. Total cash and investments available to address this liability at the end of September are \$5.1 million as compared to \$4.6 million as of the third quarter of 2007.
