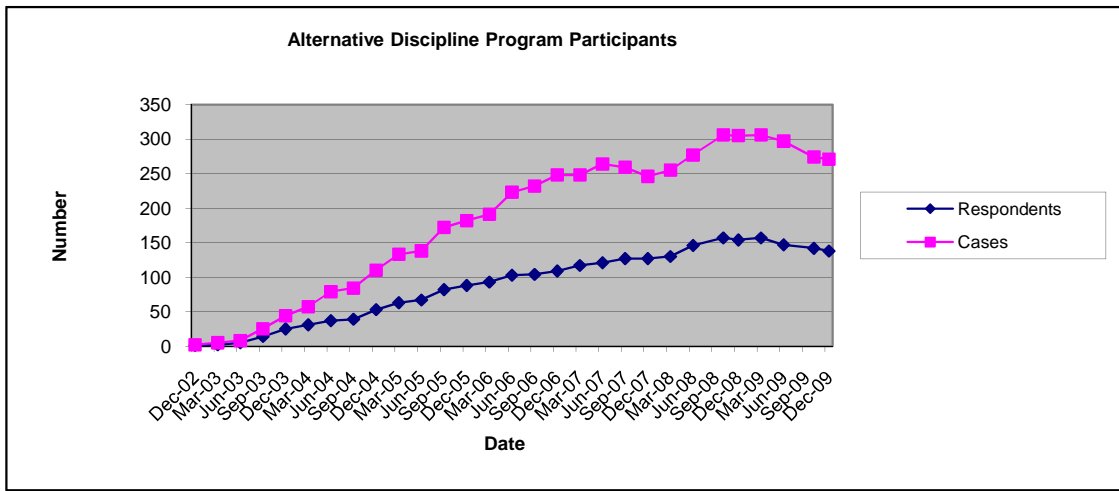

**State Bar Court Developments
(March 2010)**

1. Recruitment for three State Bar Court judges has commenced. The terms of two hearing judges and one review judge will expire on November 1, 2010. The Applicant Evaluation and Nomination Committee chaired by Judge John Munter will begin the process of evaluating applicants for the three positions.
2. As of February 18, 2010, 87 respondents have successfully completed the State Bar Court's Alternative Discipline Program ("ADP"). At this time, there are 159 respondents who are either being evaluated by the Lawyer Assistance Program for participation in the ADP or have been accepted into the State Bar Court's Program. These 159 respondents involve 308 matters in the State Bar Court.
