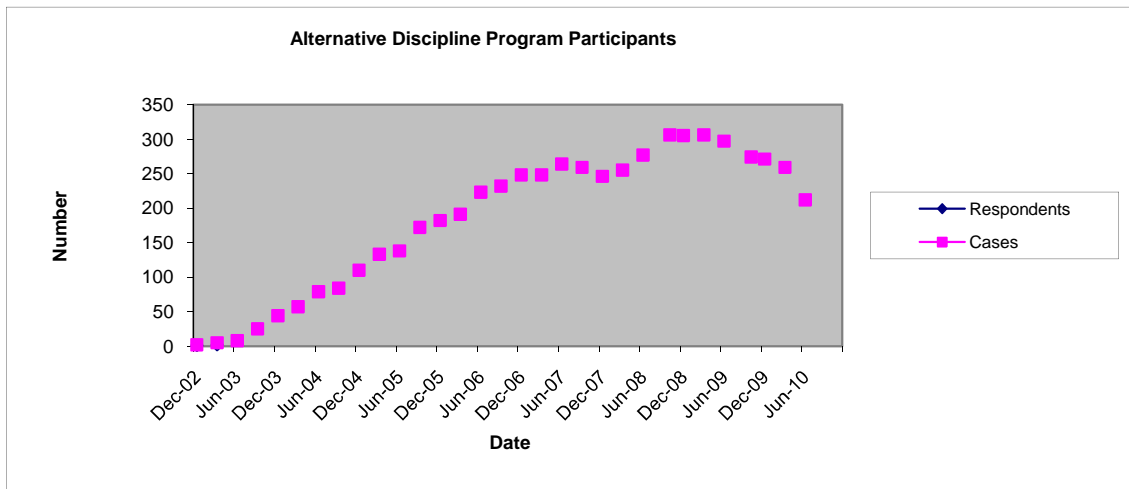

**State Bar Court Developments
(January 2011)**
