SUBJECT: Annual Investment Report as of December 31, 2010

Attached is the annual investment report for the State Bar of California as of December 31, 2010. The report is presented in a format that conforms to the investment policy adopted by the Board of Governors in May 2005. As of December 31, 2010, the market value of the State Bar's investment portfolio totaled \$86.3 million.

The time-weighted average rate of return of the investment portfolio at the end of the year is 0.58%, compared to 1.47% for the same period in the prior year. Actual investment earnings decreased approximately 52% from \$1,208,129 in 2009 to \$584,619 in 2010. This decrease is due primarily to lower short-term interest rates and duration-shortening actions taken to protect the portfolio from interest rate risk associated with longer term investments.
