Dear Applicant,

Your February 2025 California Bar Exam result is now accessible.

To determine if you were successful on the exam:

1. Visit the [Examination Pass List](#)
2. Click on 'Check results on secure server' under the Applicant-Search Only section
3. Enter your Applicant Number and File Number (you will need both)
4. If your name appears, congratulations, you have passed the exam.

If your name does not appear, unfortunately you were unsuccessful on the exam. You will receive your detailed results, including any score imputations or adjustments for the November special session, on Tuesday, May 6, 2025.

The administration of the [July 2025 California Bar Exam](#) is scheduled for July 29-30, 2025. Immediate repeaters may register for the July 2025 California Bar Exam starting on May 6, 2025, after 12:00 p.m. (PT).

The State Bar's Board of Trustees authorized a waiver of the application fee for the July 2025 California Bar Exam to applicants who were unsuccessful on the February 2025 exam. The Committee of Bar Examiners will meet today to recommend that the Board of Trustees approve, on May 9, that this credit be extended for use on one of the next three bar exams; either July 2025, February 2026, or July 2026. This credit will be applied when you complete your application for that exam. However, based on the specific language contained in the [Supreme Court order](#), the adjustment for those who took the November special session can only be applied to exams taken in 2025.
